I acknowledge that I have reviewed a copy of **Laws related to the Underage Purchase and Consumption of Alcohol**, which copy sets forth relevant provisions from Alcoholic Beverage Control Law sections **65-a** (Procuring Alcoholic Beverages for Persons Under the Age of Twenty-One Years), **65-b** (Purchase or Attempt to Purchase an Alcoholic Beverage through Fraudulent Means), and **65-c** (Unlawful Possession of an Alcoholic Beverage with the Intent to Consume by Persons Under the Age of Twenty-One Years), and section **260.20** of the Penal Law (Unlawfully Dealing with a Child in the First Degree).

I attest under penalty of perjury that I will not allow any of the beer from the keg I have purchased to be consumed in violation of sections **65-a**, **65-b**, and **65-c** of the Alcoholic Beverage Control Law, and section **260.20** of the Penal Law.

I affirm that these representations are true under penalty of perjury, and understand that I may be criminally prosecuted for making a false written statement.
